Sub: Scrutinizer's Report on postal ballot voting by way of remote voting by electronic means in respect of passing of the resolution set-out in the notice dated 13<sup>th</sup> February, 2024 through Postal Ballot

Dear Sir,

I, S. K. Patnaik, Partner of Patnaik & Patnaik, Practicing Company Secretaries, had been appointed as the Scrutinizer by the Board of Directors of IFB Agro Industries Ltd ("the Company") for the purpose of scrutinizing the Postal Ballot voting conducted by way of remote e-voting process ("e-voting") in a fair and transparent manner on the resolution contained in the postal ballot notice dated 13.02.2024 (Tuesday) ("Notice") issued in accordance with General Circular Nos. 14/2020 dated 8 April, 2020 and 17/2020 dated 13 April, 2020 read with other relevant circulars, including General Circular No. 10/2021, 20/2021, 3/2022, 11/2022, 09/2023, dated June 23, 2021, December 8, 2021, May 5, 2022, December 28, 2022 and September 25, 2023 respectively issued by Ministry of Corporate Affairs(MCA), Government of India (hereinafter referred to as "MCA Circulars").

1. The said appointment as Scrutinizer is under the provisions of Section 108 & 110 of the Companies Act, 2013 ("the Act") read with Rule 20 and Rule 22 of the Companies (Management and Administration) Rules, 2014, as amended ("the Rules"). As the Scrutinizer, I have to scrutinize the process of e-voting conducted for the postal ballot, using an electronic voting system on the dates referred to in the Notice.
2. **Management's Responsibility**  
The management of the Company is responsible to ensure compliance with the requirements of (i) the Act and the Rules made thereunder; (ii) the MCA Circulars; and (iii) the SEBI (Listing Obligations & Disclosure Requirements) Regulations 2015, ("LODR") relating to e-voting on the resolutions contained in the Notice. The management of the Company is responsible for ensuring a secured framework and robustness of the electronic voting systems.
3. **Scrutinizer's Responsibility**  
My responsibility as a scrutinizer for e-voting process is restricted to making a Scrutinizer's report of the votes cast "in favour" or "against" by the members in respect



of the resolution contained in the Notice. My report is based on verification of data and reports generated from NSDL e-voting website <https://www.evoting.nsdl.com>, till the time fixed for closing of the e-voting process i.e. till 5 p.m. on 27<sup>th</sup> April, 2024.

4. **Cut -off date**

The Members of the Company as on the "cut-off" date as set out in the Notice, i.e., 22<sup>nd</sup> March, 2024 were entitled to vote on the resolution set out in the Notice and their voting rights were in proportion to their shareholding in the paid-up equity share capital of the Company as on the cut-off date, subject to the provisions of Articles of Association of the Company.

5. **Remote e-voting process**

- I. The remote e-voting period remained open from Friday, 29<sup>th</sup> March, 2024 (9:00 a.m. IST) to Saturday, 27<sup>th</sup> April, 2024 (5:00 p.m. 1ST).
  - II. The votes cast during the remote e-voting were unblocked on Saturday, 27<sup>th</sup> April, 2024 after the conclusion of e-voting period for Postal Ballot and was witnessed by two witnesses, who are not in the employment of the Company.
  - III. Thereafter, the details containing, inter alia, the list of Members who voted "infavour" or "against" on the resolution were generated from the remote e-voting website of NSDL, i.e., (<https://www.evoting.nsdl.com>). Based on the report generated and relied upon by me, data regarding the remote e-voting was scrutinized on test check basis.
6. I submit herewith the Scrutinizer's Report on the results of the remote e-voting for postal ballot, based on the report generated, scrutinized on test-check basis, and relied upon by me as under:


